

MISSISSIPPI GULF COAST MENNIFISH MEMBERSHIP TOURNAMENT SPRING 2007

RULES

- 1) All participants must be Scuba Certified in open water by an Internationally recognized certifying agency.
- 2) All participants must use band or pneumatic powered spear guns. No gas guns, power heads, or spears powered by explosive devices may be used. Fish must be shot while the diver is submerged and brought to the boat or shore by the person spearing the fish.
- 3) All fish entered must be shot by a spear gun. No fish may be caught by hook and line.

- 4) A participant may enter only one daily limit per category.
- 5) No frozen or spoiled fish may be entered. Fish may be entered only by the person spearing the fish.
- 6) In case of equal weights, the longest fish will be the winner.
- 7) Fish may be shot from 12:01 A.M. June 15, 2007 until 11:59 P.M. June 16, 2007. Any 12 hour period within the 48 hours without a small craft advisory will constitute a tournament.
- 8) Any protest must be filed in writing within 24 hours of the tournament's end. The decisions of the Tournament Committee are final.
- 9) Diving is open to the Gulf of Mexico and adjacent waters.
- 10) Tournament Weight-in will be from 2:00 P.M. until 4:00 P.M. June 17, 2007, at Ponco's and Lefty's
- 11) One Point per pound of entered fish will be awarded toward the 2007 Club Championship.
